For all users, whether registered users or visitors, we ask that you take the time to carefully read these terms and conditions in full, as your use of this website, its information, materials and services signify your agreement to these terms and conditions. You will hereafter be bound by these terms as outlined.

LocalGigSpot has the exclusive right to at any time adjust, modify or alter these terms and conditions of use without prior notice to you. We therefore ask that you occasionally check back on this page for modifications and changes to this agreement. Your use of the website after any modification and change represents your acceptance of the changes and we will take your use of the website thereafter an acceptance of this agreement.

This agreement was written in United States (US) English, and this will supersede any translated version of this agreement where there is a conflict between the English version and the translated version.

ACCEPTABLE USE OF THE WEBSITE

Localgigspot provides a platform for Localgigspot users, particularly musicians and bands to interact with vendors and for those vendors to book the musicians and their services. We are however neither vendors nor agents, and don't provide agency functions. We have no control over any user's activity on the site, with the inclusion of interactions between users.

Localgigspot makes no representations about the accuracy, quality, or safety of any service provided by a musician or the activities or transactions between any two users of group of users. Localgigspot is a neutral venue and not a broker, and you acknowledge this fact.

You are solely responsible for your interactions with other Localgigspot Users. We reserve the right, but are not obligated, to monitor disputes between users, and shall bear no liability for interactions amongst/between users, or for any user's action or inaction.

To use this website, you affirm that you are of legal age (18 years or older in the United States) and are legally able to accept this agreement and form a binding contract. If you have not attained the legal age, you must alternatively obtain parental or guardian consent to access and use this website.

DEFINITIONS

Under these terms and conditions, the following terms shall mean:

Localgigspot or Localgigspot Services: This means the features and services we make available, including through our website at www.localgigspot.com and any other Localgigspot branded or co-branded websites.

Information: This means facts and other data about you, and this will include actions taken by users and non-users who interact with Localgigspot in any way.

Content: This means anything users post, provide or share using Localgigspot Services.

We/Us: Used interchangeably, this shall refer to Localgigspot.

You: This shall refer to users of Localgigspot.

Musicians: Localgigspot users who provide musical services and are seeking to book events.

Vendors: Localgigspot users who seek to book musicians for musical services.

REGISTRATION AND ACCOUNT SECURITY

To become a user on Localgigspot, we will ask you to provide your real name and some personally identifying information as part of a registration or log-in process. Here are the rules guiding any user's registration of a Localgigspot account:

- You are prohibited from uploading any false personal information on Localgigspot.
- You must never create an account for anyone apart from yourself without our permission.
- You are limited to only one personal account. You must not attempt to create more than one. Should we disable or delete your account for any reason, you must not create another one without our permission.
- It is not permissible for you to transfer your Localgigspot account to a third party without first getting our written permission.
- You are mandated to keep all contact information, including passwords, accurate and current.
- Children under the age of 18 may not use Localgigspot.

- You must never share your password with a third party, permit others to access your account, or act in a way that might jeopardize the security of your account.

If you are in violation of any of the provisions of these terms, we will hold you legally responsible for any and all legal costs and losses arising out of your breach. We may also terminate your use of the website without any prior warning if you breach any of these terms.

MOBILE DEVICES

We provide our services on mobile devices for free. Your carrier's normal rates and fees (like text messaging and data charges) will however still apply.

If you change or deactivate your mobile telephone number, you must update your account information on Localgigspot within 2 days to ensure that we do not send your messages to the person who acquires your old number.

Below are other terms that musicians on the website must adhere to. By making yourself available for hire for events and other musical gigs, you accept these additional terms and agree to be bound by them.

<u>Promotion</u>: You may promote yourself on the Localgigspot website with the intention of attracting vendors and hirers. With the exception of promoting your band (if you belong to one), you must not use your account to promote a third party musician.

<u>Terms of engagement</u>: You are responsible for setting your prices and must discuss terms of engagement with any vendor that hires you. Localgigspot will not be responsible and thus cannot be held liable for any dispute between you and a hiring vendor, regarding the specific terms of your engagement.

<u>Obligations to Vendors:</u> Once the initial connection has been made via Localgigspot and terms of engagement has been fashioned out with vendors, you are obligated to fulfilling your own part of the agreement between you and the vendor. We will not be held responsible for your inability to fulfill your terms.

<u>Taxes/customs and other charges:</u> If applicable, you are responsible for declaring your own taxes to the appropriate government authorities.

<u>Customer relations</u>: Musicians shall be responsible for answering all gig-related questions posed by vendors and are charged with the responsibility of managing customer relations.

OTHER TERMS FOR VENDORS

By hiring a musician through Localgigspot, you as a vendor hereby agree to:

- Agree on appropriate prices and discuss terms of engagement with any musician that you hire. Localgigspot will not be responsible and thus cannot be held liable for any dispute between you and a musician, regarding the specific terms of your engagement.
- Pay the agreed upon price as documented in writing between the parties, and make payment as at when due.
- Communicate with the musician. A vendor is charged with the responsibility of communicating with a musician in respect to detailed gig description; pricing; venue; refund, and cancelation policies. You expressly agree that Localgigspot will not be held responsible for communications and details of communication between you and musician,
- Indemnify and hold Localgigspot, its related companies, officers, directors, employees and agents harmless from and against all liabilities, attorneys' fees and costs, damages, losses, costs and other expenses in relation to your use of the services made available on or through this website.

DISPUTES

All claims, cause of action or disputes arising out of this agreement will be settled exclusively in the U.S. District Court for the Northern District of California or a state court located in Orange County. You hereby agree to submit to the personal jurisdiction of such courts for the purpose of litigating all such claims. This agreement is governed by the laws of the State of California.

INDEMNIFICATION

You hereby affirm that you will shield, indemnify and hold Localgigspot blameless against all and any claims, fees and expenses (including but not limited to attorney costs), and all damages in connection to your use of the website.

DISCLAIMERS/LIMITATION OF LIABILITY

TERMINATION

We may stop providing all or part of Localgigspot to you if you violate any terms of this agreement, or otherwise create possible legal exposure or risk for us. We will notify you by email or at the next time you attempt to access your account.

Should you decide to quit Localgigspot by yourself, you may delete your account or disable your application at any time.

PRIVACY POLICY

We are fully committed to maintaining user privacy on our website, and have designed this Privacy Policy to describe to you the use of the personal information provided us by you when you use our website. HOW WE SHARE YOUR INFORMATION

We may permit third-parties, including our authorized service providers, advertising companies, and ad networks, to place advertisements on our site. These companies may in certain cases use tracking technologies like cookies, to gather information about users who view their advertisements. Please be assured that our website does not disclose any personal detail to these third parties.
